Students currently have been working up to Entertainment, Arts, and Animation Emphasis through other courses currently offered in the BA/BS in Art program. Dixie students and faculty produced short animated film last academic year. This emphasis will allow the opportunity to see more films produced here at Dixie. • Demand? Resounding yes from current students. • Students already in Art program would benefit? Yes, we have students that have been orphaned from the discontinuation of Graphic Design with the new Design program. We have students interested in computer graphics as opposed to digital design. • New courses submitted for the program how will the workload be covered? One new course taught by adjuncts until justification for full-time faculty. The expertise in the community is available with companies that

					specialize in animation. The other two new courses will be offset by 1-year rotation as though cohort vs free classes taught every semester. • What is the growth timeline?
